



FRONIUS AUSTRALIA FSP INTERSOLAR COMPETITION 2023

TERMS AND CONDITIONS

1. General

- 1.1 The Promoter is Fronius Australia Pty Ltd (ABN: 65 144 615 896 Address: 90-92 Lambeck Drive, Tullamarine, VIC 3043, Australia).
- 1.2 Information on how to enter and prizes form part of the entry. Entry into the competition is deemed acceptance of these terms and conditions.
- 1.3 If there is any inconsistency between these Terms and Conditions and anything else that refers to this competition, these Terms and Conditions will prevail.

2. Who Can Enter

- 2.1 Entrants must be 18 years of age or older as at the date of entry to be eligible to enter the competition.
- 2.2 Entrants must be a solar company and be accredited as a Fronius Solutions Partner or Fronius Solutions Partner Plus.
